# Is "Evaluative" a Dirty Word? Can Mediators be Valuable Resources for the Participants Without Taking Sides and Without Undermining "Self-Determination"?

While the leading authorities in the area of mediation have identified 3 principle forms of mediation to include Facilitative, Transformative and Evaluative styles, the DRC frowns on the latter believing this may impede a party's ability to maintain "self-determination". Can a mediator utilize that style without violating a party's final control? What do the participants in insurance litigation want?

# 10:00 am - 11:00 am Course #2201 Litigation of Presumptive Claims Involving First Responders: Are We Missing The Forest For The Trees?

Presumptive claims for First Responders related to PTSD, heart disease, and cancer in fire service, have become one of the most difficult and contentious areas of law for adjusters and risk managers handling public sector entities. With each state individually addressing the specific problems related to this population of public servants, there is a lack of uniformity in approach to these claims, and a great deal of uncertainty about coverage. Additionally, because many presumptive laws are relatively new, there is not a body of case law defining the parameters of coverage or interpreting ambiguities in the law. As a consequence, presumptive claims are often quite contentious and technical denials are frequently asserted without regard for the secondary costs associated with same. This panel will discuss the current litigation/claims environment surrounding First Responder presumption claims, and explore secondary costs associated with the denial of presumption claims for public sector employers like police and fire departments. The focus will be on trying to get the proper balance between honoring the public policy imperatives behind presumptive laws, and denial of claims in appropriate cases.


